## 20<sup>th</sup>Annual Meeting American Academy of Veterinary Acupuncture

The American Academy of Veterinary Acupuncture (AAVA) is pleased to announce its 2025 Annual Meeting taking place on May 2-4, in New Orleans, Louisiana.

This AAVA event will be held at the Hilton New Orleans Riverside in New Orleans, Louisiana. The Hilton New Orleans Riverside Hotel is a block from Harrah's Casino and within a mile of the French Quarter, Jackson Square, and the Aquarium of the Americas. Not only is the hotel in the heart of the Arts Warehouse District but also offers an abundance of amenities including two pools, seven dining outlets, plus an expansive HealthClub featuring indoor tennis and pickleball.

We are pleased to invite credentialed veterinarians to submit abstracts of a presentation for our 2025 meeting. Submission of a paper represents a commitment to present this paper at the meeting if it is selected. Papers selected will be presented by the Author and printed in the 2025 Proceedings Book of the event.

Topics covering acupuncture and Traditional Eastern Medicine related therapies will be considered. Case studies or in-depth discussions on specific Eastern Medicine techniques will also be considered.

Abstracts must be typewritten in English, double-spaced and should not exceed a single page of 8.5" x 11" paper (A4) with 1" margins (2.5 cm). Please format the abstract in a Microsoft Word document and send it as an attached document identified as "2025 AAVA ABSTRACT" in the email subject line.

Curriculum Vitae for each author must accompany the abstract. Abstracts submitted without this information will not be considered.

### The deadline for submission is August 30, 2024.

Notification of acceptance will be sent by October 2, 2024, to those whose abstracts are selected by the AAVA Conference Committee for presentation at the meeting. The deadline for submission of the full article for the Proceedings Book will be January 13, 2025.

Keynote Lecturers (lectures of 4 hours or more) will receive honoraria of \$250 per speaking hour and travel expenses up to \$500.00. Primary authors of selected papers of less than 4 hours of lecture will receive honoraria of \$250 per speaking hour. Wet lab instructors will also receive honoraria of \$250 per speaking hour. All speakers receive a complimentary conference registration.
